# MINUTES OF THE 118<sup>th</sup> ANNUAL GENERAL MEETING OF THE ALDERSHOT DIVISIONAL FOOTBALL ASSOCIATION HELD ON THURSDAY 23<sup>rd</sup> MAY 2013 AT ALDERSHOT TOWN FC, ALDERSHOT

## 1. Chairman's Remarks

## 4. General Secretary's Report

It was proposed that the report be accepted by Steve Yeomans and seconded by Wey Valley FC, and approved by all present.

## 5. Treasurers Report

The Treasurer, Mr Steve Yeomans, presented his report as circulated and enclosed in the Meeting Pack. He briefly referred to the increased prize money and reminded clubs that affiliation fees were due by 30<sup>th</sup> June. There being no questions, it was proposed that the report be accepted by Rushmoor Celtic, seconded by Chawton Athletic, and was approved by all present.

## 7. Appointment of Accounts Verifier

The Chairman suggested that the services of DGS Associates as Accounts Verifier be retained for another season. This was proposed by John Foggo and seconded by Courtmoor FC, and accepted by all present.

## 8. <u>Rule Amendments</u>

The Chairman presented the proposed rule changes to the meeting, which were briefly explained by the General Secretary and were fully covered in the meeting pack. The amendments were all mandatory, following changes to the standard code of rules for divisional FAs, so no voting was required.

No proposals to "domestic" rules had been received.
