# MINUTES OF THE 120<sup>th</sup> ANNUAL GENERAL MEETING OF THE ALDERSHOT DIVISIONAL FOOTBALL ASSOCIATION

## 1. Chair's Remarks

The Chair, (Mr John Marchment) welcomed everyone to the 120<sup>th</sup> AGM of the Association, thanking everyone for coming in spite of the poor weather.

He began by thanking fellow officers for their help during the year and for their support in recent Cup Finals. He noted the success of local clubs in Hants Cup competitions and continued by thanking Aldershot Town for their support during the season, including use of their venue both for meetings and for hosting a number of Finals in the Cup competitions

## 2. The Minutes of the 119th Annual General Meeting

JM presented the Minutes of the previous AGM and asked for any inaccuracies or questions arising. A surname correction was noted and an appropriate amendment made. There were no other matters arising.

## 3. Adoption of the Minutes of the 119<sup>th</sup> Annual General Meeting

JM then asked that the Minutes be adopted as a true record; this was proposed by Colin Chandler, seconded by John Foggo and approved by all present.

# 4. General Secretary's Report

The General Secretary, (Mr Phil Blakey), presented his report, as circulated.

PB also thanked fellow officers of the Association for their work during the year and congratulated the clubs involved in local Cup Finals on their achievements in getting there. PB thanked the Cup Committee for their work at a late stage in managing to rearrange the finals between venues at Aldershot Town, Fleet Town and Farnborough.

PB confirmed that he would not be standing for re election but that he would still be involved with the Council. The Chair invited any questions but none were received; JM then thanked PB for his tireless work on behalf of the Council and led a round of applause in appreciation.

#### 5. <u>Treasurers Report</u>

The Treasurer, (Mr Eddie Spraggett), presented the accounts as circulated.

PB declared that all the Officers were elected as nominated and passed the chair of the meeting back. JM, on behalf of the Officers, thanked the meeting for the reelection of the new team and for the clubs' support in ADFA business during the year.

#### 7. Appointment of Accounts Verifier

JM proposed that the services of S7 Consultants as Accounts Verifier be approved for the season. This was seconded by PB and approved by all present on a show of hands.

#### 8. Rule Amendments

PB explained that there was one rule change proposed this year, which was necessary because ADFA Meetings now needed to be held at defined times. Acceptance of the changes was proposed by Courtmoor, seconded by Fleet Spurs and approved by all present

#### 9. Meritorious Service to Football Awards

JM paid tribute to everyone involved in promoting football at local level and encouraged clubs to consider nominating individuals whose contribution could be recognised in this way. #### 11. Any Other Previously Notified Business

<u>Extra Time in ADFA Cup Competitions</u>. PB explained that Hants FA had decided to go directly to penalties in their Cup Competitions in games when the scores were level at the end of normal time, (excluding extra time being played). Mixed views were expressed and PB said that JM would email clubs for further feedback and then advise further.

Finally, JM thanked all clubs for their efforts in keeping local football going and assured clubs that the ADFA could continue to press for their best interests at all representations with local councils and Hants FA . JM once again thanked everyone for their attendance and wished everyone a good summer before the start of the new season
