

MINUTES OF THE 130th ANNUAL GENERAL MEETING OF THE ALDERSHOT DIVISIONAL FOOTBALL ASSOCIATION

1. Chairman's Remarks

The Chairman, Mike Gardner (MG), opened the meeting welcoming everyone to the 130th AGM of the Association. Shire United defended their title in this Cup and they were too strong this season for their opponents Wheatsheaf FC running out 5-1 winners in a very entertaining game. 9 clubs entered this competition.
